

#### INFRASTRUCTURE

#### **Class rooms :**

The smart classrooms are naturally light-filled, well-ventilated, and equipped with the newest educational audio-visual technology along with comfortable seating to promote easy learning. Clear understanding and focused discussion are supported in the smart classroom setting. Everything needed for virtual learning is available in the smart classrooms.



#### Library :

The college library is spacious well-furnished, well-stocked, and wellarranged. The reading hall is situated such that natural light is used to its fullest potential, which helps teachers and students learn. The goal of the DVCOP library is to provide information to pharmacy students at every level. There are adequate number of text and reference book titles and volumes in the library. Additionally, it subscribes to magazines, e-books, k-Hub. The library is automated using library automation software has subscribed and national and international journals that are necessary for the pharmacy sector.



#### Laboratories :

The institute offers well-designed, spacious laboratories that are furnished with modern teaching and training resources for a range of pharmacy-related topics. The laboratories are well-planned in accordance with national regulatory bodies norms and regulations as well as international standards. A large instrumentation room with a variety of advanced analytical equipment is set up independently.

#### **Museum:**

The college has created a museum with a variety of formulations, including oral liquids, lotions, ointments, solid dosage forms, Ayurvedic remedies, dental items, cosmetics, and more. The college also maintains herbarium and an ancient drug museum.



#### **Medicinal Plant Garden :**

The College has land for medicinal plant garden which contain more than 50 medicinal plants. It also serves as a conservation source of standard specimens.



#### **Canteen:**

DVCOP has the facility of spacious, clean and hygienic canteen that caters to the taste of all students. It provides all type of nutritious and hygienic eatables and beverages to cater to the students, staff and visitors.

#### **Department of Pharmaceutics :**

The branch of Pharmacy known as Pharmaceutics handles every aspect of converting a novel chemical entity (NCE) into a dosage form that can be utilized in clinical settings safely and effectively. Examples of these dosage forms include tablets, capsules, oral liquids, ointments, injectables, aerosols, and transdermal patches. Students enrolled in the Pharmaceutics department receive training in a variety of formulation development methodologies and associated quality control issues in wellequipped laboratories. The Department's primary equipment includes a Centrifuge, Autoclave, Hot air sterilizer, BOD incubator, Tablet coating pan, Ampoule washing machine, Tablet punching machine, and Dissolution test instrument.





#### **Department of Pharmaceutical Chemistry :**

The Department of Pharmaceutical Chemistry is an essential component of any pharmacy education program, as it covers several aspects of new drug discovery and development. The department teaches General Chemistry, Biochemistry, Pharmaceutical Organic Chemistry, Medicinal chemistry, Inorganic chemistry, and Pharmaceutical Analysis for the four-year B. Pharm program. Major instruments in the department include a HPLC, UV Spectrophotometer, Photofluorimeter, Flame Photometer, Nepheloturbidometer, pH meter, Colorimeter, Conductometer, Muffle furnace etc.

#### **Department of Pharmacology :**

The pharmacology department lays strong emphasis on education in pharmacology, toxicology & other related subjects. A primary objective of pharmacology is to investigate the fundamental aspects of molecular bioregulatory mechanism of the cell and understand how the drugs act in order to develop new drug for treatment of diseases. Toxicology examines toxicity and adverse effects of developed drugs, mechanisms of chemical agents. The department is equipped with software for various practicals. The major equipments available in the department Actophotometer, Analgesiometer (Tail flick), Pole climbing apparatus etc.

#### **Department of Pharmacognosy :**

The science that studies medicine made from natural sources is called Pharmacognosy. The field of Pharmacognosy is concerned with the remarkable progress in the understanding and application of biologically derived therapeutic compounds (plant, microbe, and animal products) for both human and veterinary applications. The major instruments available like Soxhlet apparatus, Muffle furnace, Projection microscope, etc.

- 4. The student should carry identity card with him regularly and the identity card should be produced when demanded by the authority of the institute. Any changes in the address of student must be intimated by him/her in writing to the college office immediately.
- 5. The student is required to submit the assignment failing which he/she shall be subjected to disciplinary action.
- 6. The Vehicles should parked on place notified and the vehicles parked elsewhere i.e. Other than parking zone shall be confiscated.
- 7. Student should drive safely inside the campus as well as outside the campus. For two wheeler users, use ofhelmet is compulsory.
- 8. The student should not cause any damage to the institute's property. The damage caused shall be recovered from student immediately.
- 9. The attendance for the tests and tutorials conducted in the College is compulsory.
- If the student is found weak in certain subjects he/she will have to attend extra classes as notified and make the required progress to come at par with the other students.
- 11. Strict silence should obsen/ed in the library. Loitering is corridors is strictly prohibited.
- 12. The student coming late shall not be allowed to enterthe class.
- 13. The student should read the notices displayed on the notice board regularly and the College will not be responsible for the loss or any disadvantage due to negligence of reading notices on the part of the students.
- 14. In case, a student requires to remain absent for some reason, he/she will be required to take the prior permission of the Head of the Department / Teacher co-ordinating.
- 15. Use of the phones/cameras/camera phones is prohibited in the campus.
- 16. Smoking, drinking (alcohol) and use of 'Drugs' is strictly prohibited in the college premises and the hostel.
- Mal-practices during all examinations and tests will be taken seriously and disciplinary action will be taken against the defaulters. Punishment for mal- practices during examinations would be very serious and may involve debarring from examination.
- Ragging of students in any form within or outside the college and hostel is strictly prohibited. Defaulters will be strictly dealt with as per anti ragging ordinance.
- 19. If any of the statement made in application form or any information supplied by the student to college authorities is found to be false or incorrect later on, his/her admission will be cancelled, fees forfeited and he/she will be expelled from the college and prosecuted as per rules if deemed necessary.
- 20. The above rules of discipline are always subject to change, modification,

addition, omission, alterations as and when the Management feels it fit and proper and the decisions of the Management shall be final.

#### **Anti-ragging Rules & Regulation :**

UGC regulation on curbing the menace of ragging (under section 26 (I) (g) of the university grant commission act, 1956 New Delhi - 110002,the 17<sup>th</sup> June 2009)

#### Ragging in any form is strictly prohibited in the institute.

- 1. Ragging within the Institute campus and hostels is strictly prohibited.
- 2. Ragging in any form is prohibited also in the private lodges! buildings where these institute students are staying.
- 3. No person including students! staff! faculty shall participate or abet or propagate ragging in any form.

#### What constitutes ragging ?

- (a) Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student.
- (b) Indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological or physical harm or to raise fear or apprehension thereof in a fresher or a junior student.
- (c) Asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.
- (d) Teasing, embarrassing, humiliating, assaulting or using criminal force or criminal intimidation, wrongful restraining or confining or causing grievous hurt, kidnaping, and extortion or molesting or committing unnatural offences or causing death or abetting suicide, use of criminal force, criminal trespass and intimidation.

#### **Punishments :**

Ragging is a cognizable offence under the law and the punishments to be meted out have to be exemplary and justifiably harsh to act as a deterrent. It may include :

- (a) Cancellation of admission, suspension, rustication or expulsion from the Institute / Hostel.
- (b) FIR with the police and arrest.
- (c) More severe punishmentwherejustified such as fine / imprisonment etc.
- (d) Collective punishment may be imposed where involved persons are not identified.

#### Admission cancellation & refund of fees :

It will be as per the rules of admission regulatory authority Maharashtra State.
